Objet : Modification mineure du certificat d'autorisation délivrée le 5 avril 2019

Madame Lizotte,

À ce jour, le certificat d'autorisation modifiée délivrée le 5 avril 2019 (V/Réf : 3215-14-019) nous permet d'accueillir un maximum de 975 personnes à Katinniq. Cette dernière demande de modification avait pour objectif d'augmenter la population autorisée à Katinniq de 875 à 975 personnes afin d'atteindre un niveau opérationnel d'environ 900 personnes hébergées.

Depuis la réception de cette modification, le niveau opérationnel a plutôt été établi à 875 personnes hébergées. Ceci correspond à la contingence équivalente à 10% des chambres qui ne peuvent être utilisées, tel que précisé dans le document de demande de modification de 2019. Cette contingence est requise en raison des contraintes opérationnelles, telle la rotation du personnel, les chambres réservées, le nettoyage et la maintenance des chambres ou encore les bris mécaniques d'avion ainsi que les mauvaises conditions météorologiques ne permettant pas un décollage de l'avion.

En 2020, les défis opérationnels liés à la crise sanitaire ont modifié nos opérations et ceux-ci ont été amplifiés par le conflit de travail de 2022. Ces défis ont causé une accumulation de retards reliés aux activités de notre projet actuel de la Phase II et III (V/Réf : 3215-14-019 du 11 juillet 2017). Considérant que ces défis opérationnels sont maintenant atténués ou résolus, nous aimerions avoir l'opportunité de rattraper les retards accumulés en augmentant le niveau opérationnel de personnes hébergées à 975, soit le maximum actuellement autorisé.

Ainsi, afin d'atteindre ce niveau tout en respectant la contingence opérationnelle d'environ 10%, il faudrait un total d'environ 1 085 chambres versus les 975 chambres actuelles. Tout ajout de chambres se limitera à l'aire résidentielle existante à Katinniq. Cette dernière ne nécessitera pas d'agrandissement de sa superficie.

Il est important de préciser à nouveau que la population maximale autorisée à Katinniq n'est pas modifiée et demeure à 975 personnes, mais également qu'aucune augmentation de la capacité de traitement des eaux usées domestiques ou de l'eau potable n'est requise. Les capacités de traitement des usines existantes correspondant à 1 035 personnes (393 m³/jour et 452 m³/jour respectivement). Les modifications seront donc limitées à

l'installation de modules d'hébergement ainsi qu'à leurs raccordements aux éléments existants soit : le complexe d'hébergement, le réseau électrique et aux réseaux d'aqueduc et des eaux usées domestiques.

Puisque les nouveaux modules seront localisés sur une superficie déjà aménagée, que le nombre maximal de personnes autorisé ne change pas, qu'aucun changement n'est requis aux installations de traitement de l'eau potable et des eaux usées, et qu'aucun impact environnemental n'est anticipé, nous avons espoir que nous puissions recevoir une réponse rapide de votre part. Nous comprenons également que la CQEK se rencontre au début du mois de septembre et nous apprécierions, dans la mesure du possible, que la présente demande puisse être présentée à ce moment. Ces actions nous aideraient à poursuivre de façon efficace la réalisation de notre projet. En parallèle, nous considérons pouvoir entamer des travaux mineurs de terrassement et de livraison des modules dans l'attente de votre réponse.

Finalement, nous sommes d'avis que le libellé du certificat d'autorisation délivré le 5 avril 2019 aurait dû être libellé similairement à ce qui a été libellé dans l'autorisation émise le 5 juillet 2013, soit en une augmentation de la capacité d'accueil des travailleurs, et non pas en termes d'agrandissement du complexe résidentiel Katinniq. De plus, nous sommes d'avis qu'un agrandissement qui se limite aux superficies déjà aménagées ne devraient pas faire l'objet d'une modification du certificat d'autorisation comme cette activité n'engendre aucun impact additionnel sur le territoire, contrairement à une augmentation de la population au-delà de la limite autorisée qui elle, peut potentiellement engendrer de nouveaux impacts sur l'environnement (exemple : augmentation du traitement et du rejet des eaux usées). Ainsi, nous suggérons que les prochains libellés soient formulés de manière que l'augmentation de la population ou un agrandissement à l'extérieur des aires déjà aménagées soient des déclencheurs pour une modification du certificat d'autorisation.




Figure 1 : Zone d'aménagement proposée ainsi que l'aire résidentielle à Katinniq
